- Regulatory Strategy Development:
 - Develop, implement, and collaborate on the building of Moolec's regulatory strategies and the identity preservation program to achieve compliance for GM organisms and quality food products derived from them.
 - Prepare and submit regulatory documents such as food GRAS notifications to the US-FDA and permits and other approvals from USDA-APHIS.
 - Reviews with USDA-APHIS, compliance for shipments, seed increases and field trials permits, and others.
 - Address food and environmental regulatory obligations in other countries of Moolec's operation.
 - Work closely with the Field Operations Team to plan and execute identity preservation activities.

• Regulatory Compliance & Documentation:

- Acquire necessary permits, compile and maintain regulatory compliance documentation, and report to government agencies.
- Monitor regulations and assess potential impacts and risks posed by changing the global product regulatory framework.
- Create and maintain compliance documents.



• Customer & Supplier Interaction:

- Provide customers with regulatory information in accordance with US-FDA/USDA/other agencies regulations, customer-specific guidelines, and international regulations.
- Collaborate with suppliers, customers, and other value chain participants to foster product safety management and information exchange.
